



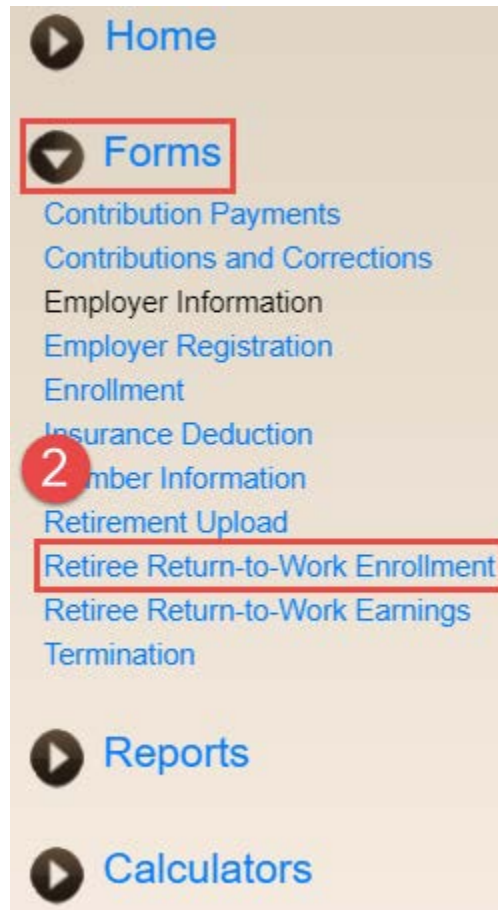
Retiree Return-to-Work Enrollment

LOUISIANA SCHOOL EMPLOYEES'
RETIREMENT SYSTEM

Purpose: To provide instructions for enrolling retirees who return to work under the provisions of La. R.S. 11:1006 earnings limit (RTW1006) and La. R.S. 11:1007 full-time bus operator shortage (RTW1007).

1. Log in to [LSERSWeb](#).
2. Click Forms and choose Retiree Return-to-Work Enrollment.



3. Enter the member's social security number and click Search. The member's information will populate. Employer name will default to your specific agency based on your login.

Enrollment Information

A retiree under the Regular Service, DROP or IBRP plan of retirement can be re-employed in any position covered by LSERS as a full-time, part-time, temporary, or substitute employee. If the earnings of the retiree in any fiscal year (July 1 - June 30) exceed the earnings limit for that fiscal year, the retiree must reimburse LSERS. Any retiree of this system who returns to work under R.S. 11:1007 within the twelve-month period immediately following the effective date of his retirement shall have his retirement benefit suspended for the duration of such active service or the lapse of twelve months after the effective date of his retirement, whichever occurs first.

Unsheltered Contributions shall be withheld and remitted to LSERS via the Contribution Report.

A-B must be completed prior to enrolling RTW1007.

- Enter the Enrollment Date.
- The declaration must be uploaded here. Please see the template at the end of this procedure.

NOTE: Retiree RTW1007 enrollments will be terminated by LSERS on June 30th of each year. You must re- enroll full-time bus operators every year upon completion of the BESE certification. The online enrollment form for RTW1007 will only be available from 7/1 to 8/31 each year. The Declaration to LSERS should be uploaded at the time of enrollment; the enrollment will not be accepted until received.

- Be sure to check the box for the Form 2F. The 2F paperwork is to remain with the employer. Then click on Submit to complete the enrollment.

Since this applicant is being enrolled on or after January 1, 2013, the employer must provide the Forfeiture of Benefits Attestation, [Form 2F](#), to the applicant for attesting to the provisions of La. R.S. 11:293.
